### \_\_\_\_\_ Initial Home Assessment Review (for NEDC clients) - \$315

- For regular agency/individual home study report review: Includes consultation and referral to area licensed agencies and review of home study for NEDC. Includes review and completion of 4.0 credit hours of NEDC training module education, certificate of completion, and training materials.

### \_\_\_\_\_ Subsequent Home Assessment Update Review (for NEDC clients) - \$105

- Includes consultation and review of home study update for NEDC.

### \_\_\_\_\_ Embryo Adoption Training Modules (Nightlight Snowflake & private clients) - \$40

- For Nightlight SFE or private clients: Includes review and completion of 4.0 credit hours of training module education, certificate of completion, and training materials.

### \_\_\_\_\_ Open Donation Agreement Mediation Service (for NEDC clients) - \$1,785

- Includes service for embryo transfer through NEDC with up to two donor agreements.
- *If more than 2 donor agreements are mediated, then additional charges (see fee below).*
- Includes consultation and planning with recipients and donor(s) in preparing for the open donation relationship; negotiation and completion of the signed Open Donation Agreement; communication exchange services for the recipient and their donor(s) for up to one-month from embryo transfer, and support sessions as requested.

### \_\_\_\_\_ Additional Donor Agreements (NEDC)- Open Donation Agreement - \$470

- Additional donor agreements are charged at \$470 per donor agreement.
- Includes consultation and planning with recipients and donor(s) in preparing for the open donation relationship; negotiation and completion of the signed Open Donation Agreement; and communication exchange services for the recipient and their donor(s) for up to one-month post transfer, and support sessions as requested.

### \_\_\_\_\_ Third-Party Mediation Services (Open Adoption) - \$100 per hour

- Optional services to clients who wish to have a 3rd party continue to facilitate their open communication after the one-month embryo transfer period. Hourly rate includes time involved for services including phone calls, emails, documentation, etc.
- Services also available to those who have finalized a domestic adoption and have an open adoption relationship with a birth parent(s).

### \_\_\_\_\_ Psycho-Educational Consultation for Fertility Clinic - \$100 per hour

- Includes consultation, education, support sessions, and evaluation of recipients seeking services from a fertility clinic or donation bank. Hourly rate includes time involved for services including phone calls, emails, documentation, etc.

### \_\_\_\_\_ Support Sessions and Coaching - \$99 per hour session (\$50 for NEDC clients)
