



NEDC FEE SCHEDULE

The three most variable costs with associated with the frozen embryo transfer with donor embryos are the home study cost, the cost of the medications, and embryo donor fees. Home study costs vary from state to state and from agency to agency; medication prices vary depending your insurance coverage and your chosen pharmacy; and donor fees include lab, shipping, and handling costs paid by the NEDC to facilitate the donation of the embryos to the NEDC.
